Section 03 - Hazard Identification

Inhalation..... May cause slight respiratory tract irritation. Symptoms include a burning sensation, coughing, wheezing, laryngitis, shortness of breath, nausea, and vomiting.

Skin Contact / Absorption..... May cause slight skin irritation. Is absorbed through the skin.

Eye Contact..... Exposure to dust may cause mechanical eye irritation.



Ingestion.....May be mildly toxic by ingestion.

Section 04 - First Aid Measures

Inhalation..... Remove victim to fresh air. Give artificial respiration only if breathing has stopped. If breathing is difficult, give oxygen. Seek immediate medical attention.

Skin Contact / Absorption.....Remove contaminated clothing. Wash affected area with soap and water. Seek medical attention if irritation occurs or persists.

Eye Contact..... Flush immediately with water for at least 20 minutes. Forcibly hold eyelids apart to ensure complete irrigation of eye tissue. Seek immediate medical attention.

Ingestion..... Do not induce vomiting. If vomiting occurs, lean victim forward to prevent breathing in vomitus. Give 1-2 glasses amounts of water. Do not give anything by mouth to an unconscious or convulsing person. Seek immediate medical attention.
